BY SIGNING THIS LEGAL DOCUMENT, YOU ARE GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE IN CERTAIN CIRCUMSTANCES, SO PLEASE READ CAREFULLY.

This General Release is intended as a waiver of liability for Antilles School, its trustees, administration, faculty, staff, coaches, representatives, agents, and volunteers, collectively known as the "School" for their roles, participation and involvement in events, physical and/or athletic activities and programs, including but not limited to organized sport events, off-campus field trips and travel, service learning and community service activities, campus computer and internet usage, organized trips, travel to- and-from off-campus events, dramatic and musical performances, recess play, on-campus student associations and club activities, that extend beyond its academic duties, scope and responsibilities covered by its charter, regulations and insurance policies. Participation in such activities is made available to eligible students, and is conditioned upon the Student's and Parent's/Guardian's acknowledgement and consent to the terms and provisions set forth herein, and execution of this general waiver and release of liability.

I/We understand and appreciate that there are inherent risks involved in all such activities and in signing this Waiver, I/We acknowledge such risks and herein agree to indemnify and hold harmless the School for any injury to Student or loss or damage to Student's personal property arising from, or in any way resulting from, Student's participation in these activities, unless such injury, loss or damage is caused by the willful or intentional misconduct or sole negligence of the School while acting within the scope of its duties and responsibilities.

I/We understand and acknowledge that despite the precautions taken by the School, there are potential risks associated with certain activities, and understand that the choice to participate brings with it the assumption of those risks and results which are a part of these activities. I/We further acknowledge that certain activities require a minimum level of fitness and health, and herein warrant being physically fit to participate.

If it is necessary or desirable that the Student be provided medical treatment, I/We hereby give permission and authorize the School to provide and/or seek medical attention including, but not limited to, first aid, school nurse assistance, cardio pulmonary resuscitation (CPR/AED), professional emergency medical care and transport, and I/We agree to be financially responsible for the cost of any medical care afforded to the Student, and will hold the School harmless from any demand or responsibility for such costs.

In exchange for being permitted to participate in School's dramatic, athletic, or musical performances, recitals or events, I/We herein agree and irrevocably authorize the School to record Student's likeness and voice on a video, audio, photographic, digital, electronic or any other medium. The School in its sole discretion shall use, reproduce, exhibit or distribute in any medium, and in any public or private media, Student's name, visual likeness and personal quotations in connection with these recordings or any other recordings of Student participating in school and school-related activities, in connection with its publications, brochures, materials, website, and communications of the School, for any purpose that the School deems appropriate, including promotional or marketing efforts. I/We release the School from liability for any violation of any personal or proprietary right I/We may have in connection with such use. I/We understand that all such recordings, in whatever medium, shall remain the property of the School. Any parent wishing to opt-out of this clause may let the School know in writing on the back of this form.

The Student's and/or Student's representative's right to recover for claims covered by School's Insurers or any other Third-Party Insurers shall not be limited and is not abrogated by the terms and provisions of this General Waiver and Release of Liability.

I/WE HAVE READ THIS AGREEMENT CAREFULLY AND FULLY UNDERSTAND ITS CONTENT. I/WE HAVE LEGAL AUTHORITY TO EXECUTE THIS WAIVER AND RELEASE, ON BEHALF OF THE STUDENT NAMED HEREIN, AND DO SO VOLUNTARILY.
